

By applying for membership and signing the membership application, you are agreeing to the following statements:

- Beginning in 2025, the course will provide a tee time management system that will allow for online reservations.
 - I will arrive in a timely fashion for my tee times
 - I will call the clubhouse a minimum of 24 hours prior to any tee time cancelation.
 - I will ALWAYS check in with the clubhouse prior to playing. This
 includes when I walk.
 - I will always check with the clubhouse staff and receive approval anytime I would like to start on a hole other than #1.
 - I will check in with the clubhouse staff prior to re-playing and pay for the use of golf carts prior to playing
 - I will play in groups of 4 or less. There are rare occasions when a 5some could be permitted. I will always clear this with the clubhouse staff first.
- I will take care of any rental equipment in my possession and will report and take financial responsibility for any damage I am responsible for
- I will take care of the golf course by abiding by the golf cart driving rules:
 - I will keep golf carts a reasonable distance from all greens normally a minimum of 30 feet
 - I will abide by the daily golf cart rules (90 degrees, cart path only, etc.) as weather and course conditions dictate
 - I will keep golf carts on the cart path around all tee boxes
 - I will not remove fence posts or move rope to change driving directions
 - Other than on #4, I agree to keep carts on the cart path on all Par 3's
- When using the driving range, I will do my best to keep the range balls in the boundaries of the driving range
- When using the driving range, I will only hit from the designated areas on the range tee box

The owners understand that non-members and visitors are most often those who take advantage of the above-referenced items. However, it is the responsibility of our members to provide an example for our guests!
